References are being received seeking clarification with regard to payment of Transfer Travelling Allowance to these contractual employees.

After careful consideration, the Government has decided to grant Transfer Travelling Allowance to contractual appointees at par with their regular counter parts on the minimum of the pay band plus grade pay of the post against which they have been appointed on contract basis provided the transfer is in the interest of public service and not on individual's request.
